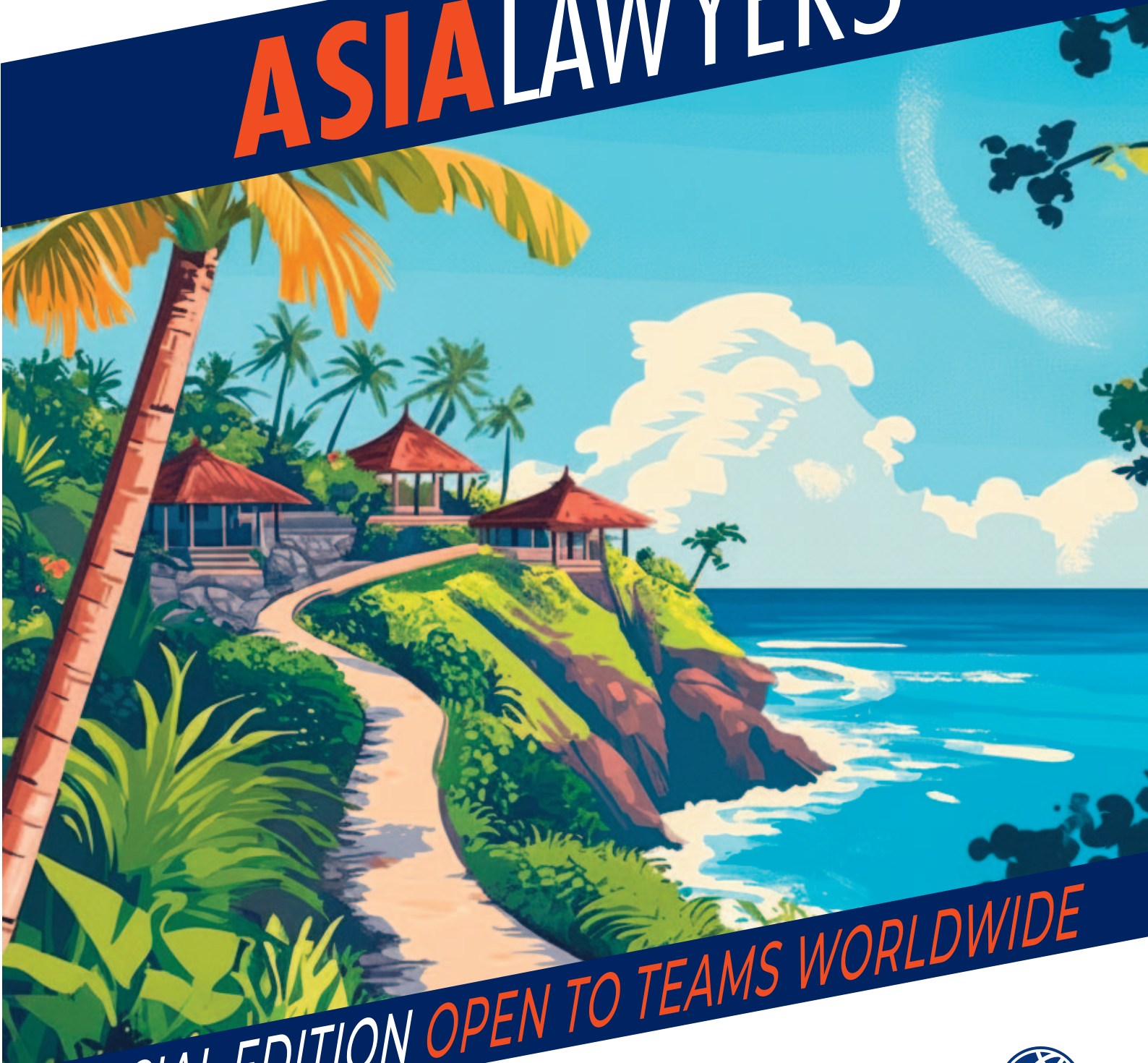

LAWYERS' ASIAN FOOTBALL CUP

CONCEPT

AsiaLawyers (Asian Football Cup of bar associations and law firms) is a continental competition derived from the **Mundivocat** (Lawyers' Football World Cup), which was established in 2007 and was originally reserved for lawyers from across Asia.

This year, in light of the unique host destination, **the tournament will exceptionally be open to teams from outside Asia**, allowing non-Asian teams who wish to join us, to register and take part in the competition.

The tournament will take place over four days, from **Thursday, 22 April to Sunday, 25 April 2027.**

A welcome cocktail reception will be held on **Wednesday evening.**

Each team will play **at least four matches**, with match durations ranging from **50 to 80 minutes**, depending on the competition category and the team's progress throughout the tournament.

REFEREEING

To ensure the competition runs smoothly, the organisation is working with the Football Association of Indonesia, which will provide the necessary referees.

There will be **3 referees** and **1 delegate** for each 11-a-side match. For 5 and 7-a-side football matches, there will be **1 referee.**

REGISTRATION

There is no limited number per city or country and no qualification system.

TROPHIES

Prizes will be awarded at each tournament:

- **Champions, second and third:** cups and medals (gold, silver, bronze).

- **All other teams** will receive a cup with their respective ranking.

- **Special prizes** will also be awarded in each category for the best player, top scorer, best goalkeeper, best manager and most fair play team.

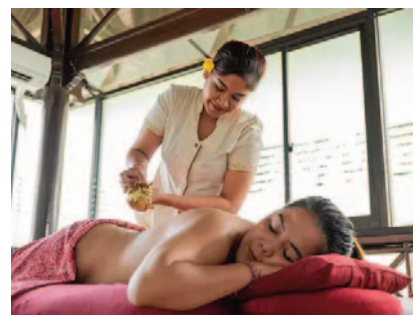
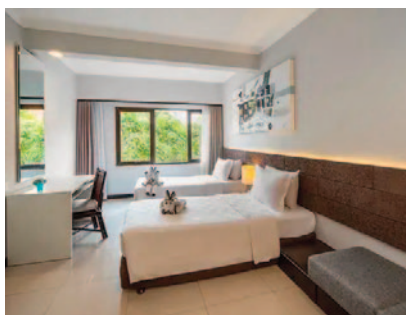
Prime Plaza Hotel & Suites Sanur

All delegations will be staying at the **Prime Plaza Hotel & Suites Sanur -Bali**, which will also serve as the event's home base. This four-star resort sits just few minutes from Sanur Beach.

The hotel offers modern Balinese-style rooms set around a lush tropical courtyard and a stunning 110-meter free-form pool, along with two restaurants,

two bars, a fitness centre and a spa - everything you need to recharge batteries between matches!

Located 30 minutes from I Gusti Ngurah Rai International Airport and 30 minutes from the Bali United Training Center, the hotel is ideally positioned. Round-trip transfers between the hotel and the football pitches will be provided.





RATES

Registration fees at the 7th edition of the Asialawyers consist of cost of registration per team AND per person.

REGISTRATION FEE PER TEAM

11-a-side: 3 000 €

7 Men: 1 500 €

5 Women: free of charge

These costs include:

All expenses for the organization of the tournament, the provision of football pitches, balls, refereeing, water on the pitch, touch-line medical assistance, cups, trophies, and medals.

Individual package

Rates per person based on a double/twin or individual room occupation in Prime Plaza Hotel & Suites - Bali.

It is mandatory and non-derogatory, given the financial commitments made to our partners, to reserve your accommodation through the organization when participating in the Asialawyers.

These prices *include*:

1. TEAM REGISTRATION

1.1. The tournament is exclusively reserved for teams composed of lawyers, notaries, magistrates, court bailiffs and, more generally, all graduates of higher legal studies.

1.2. Each team must include:

- 11-a-side: 13 to 26 players
- 7-a-side: 9 to 15 players
- 5-a-side: 6 to 13 players

2. PLAYER QUALIFICATIONS

2.1. Team Composition

Each team must include:

- Lawyers, notaries, magistrates or court bailiffs practicing or having practiced the profession;
- Holders of a higher education qualification in law, certifying at least three years of study.

In addition to the aforementioned cases, each team may add, in accordance with the conditions set out in paragraph 2.2:

- Law students who have completed at least the first year of a higher education program in law
- Exemptions (permanent employees of law firms, notarial offices, or judicial institutions)

2.2 Students and exceptions players

5-a-side:

- 1 student per team
- 2 exceptions per team

7-a-side:

- 1 student per team
- 3 exceptions per team

11-a-side:

- 2 students per team
- 3 exceptions per team*

**Special case: 11-a-side teams without any students may include a fourth exception.*

In this case, a document certifying the status of each person must be provided (players, exceptions and students).

Age limits for exception players:

- Five Women: +30 years old (born before 31/12/1997)
- Seven Men: +30 years old (born before 31/12/1997)
- Classic: +30 years old (born before 31/12/1997)
- Master: +35 years old (born before 31/12/1992)
- Legend: +45 years old (born before 31/12/1982)

2.3 Validation of exemptions

No exemption request will be accepted from a non-lawyer who plays or has played football for a professional, semi-professional or other club for which he has received remuneration. To be accepted, requests for exemption must be sent to the organization no later than 30 days before the start of the tournament.

All the above conditions relating to exemptions are imperative, but not sufficient to guarantee the validation of an exemption. The final decision remains with the executive committee, made up of M^e Pinatel (founder of Mundiavocat) and Mr Pagnier (tournament director).

3. TEAM COMPOSITION

Classic

- Lawyers (or other authorized professions) without age limit and cases mentioned above

Master

- Lawyers (or other authorized professions) aged over 35 (born before 31/12/1992) and cases mentioned above.
- 5 lawyers over 30 (born before 31/12/1997)

Legend

- Lawyers (or other authorized professions) aged over 45 (born before 31/12/1982) and cases mentioned above.
- 5 lawyers over 40 (born before 31/12/1987)

Seven Men

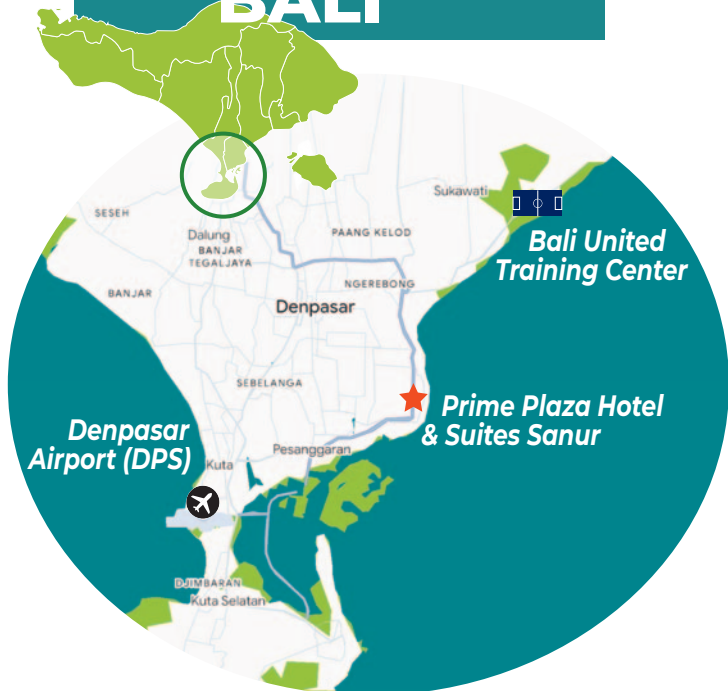
- Lawyers (or other authorized professions) without age limit and cases mentioned above

Five Women

- Lawyers (or other authorized professions) without age limit and cases mentioned above
