# REQUIRED DOCUMENTS – COMPULSORY

**Thank you for submitting the required documents by April 4<sup>th</sup> 2020 at the latest:**

- A copy of the lawyer's card, for each player. A professional certificate or diploma if particular case (student, law firm employee).
- A copy of the passport, for each player and guest.
- A medical certificate of less than one year authorizing to play competitive football under the conditions of MUNDIAVOCAT (6 to 7 games of 80 minutes in Classic and 60 minutes matches in the other tournaments in 8 days), for each player.
- 1 passport color photograph, for each player and its guests.
- 1 player sheet dully filled in and signed, for each player.

## EXEMPTIONS

**For the MUNDIAVOCAT, to build your team we may accept:**

### **11-a-side, Classic Tournament (without age limit):**

- 3 exemptions over 30 years old per team for non-lawyer player, member of the legal community or of the law-firm,
- 2 law students or trainee lawyers over 22 years old

### **11-a-side, Master Tournament (more than 35 years old):**

- 3 exemptions over 35 years old per team for non-lawyer player, member of the legal community or of the law-firm,
- 5 lawyers players over 30 years old

### **11-a-side, Legend Tournament (more than 45 years old):**

- 3 exemptions over 45 years old per team for non-lawyer player, member of the legal community or of the law-firm,
- 5 lawyers players over 40 years old

### **11-a-side, Super Legend Tournament (more than 55 years old):**

- 3 exemptions over 55 years old per team for non-lawyer player, member of the legal community or of the law-firm,
- 5 lawyers players over 50 years old

### **5-a-side, Classic Tournament Men & Women (without age limit):**

- 2 exemptions over 30 years old per team for non-lawyer player, member of the legal community or of the law-firm,
- 2 law students or trainee lawyers over 22 years old

**Exempted players playing or who have played in football clubs at professional or semi-professional level are not accepted. These conditions are mandatory but not sufficient to guarantee an exemption.**

**For any request for exemption, you must send, during the registration and by March 20th 2018 at the latest, the required documents:**

- An individual certificate justifying their activity / profession in the judiciary industry,
- A sworn declaration signed by the captain of the team certifying that the player asking for an exemption is not and has never been player in a professional club, a semi-professional club or any other club in exchange of payment,
- A medical certificate of less than 1 year,
- 1 passport color photograph

## 1 - Payment of the tournament's registration and accommodation fees

In order to formally record your registration, you must adhere to the following schedule of payments:

**Before October 30th, 2019:** 1<sup>st</sup> deposit of 5 000 euros / 2 500 euros for the 5-a-side tournament

**Before December 2019:** 2<sup>nd</sup> deposit of 5 000 euros / 2 500 euros for the 5-a-side tournament

**Before February, 2020:** 3<sup>rd</sup> deposit of 5 000 euros

**Before April 30th, 2020:** Balance.

Payment of the team registration fees and those related to accommodation and additional services have to be paid to Corporate Sport Organisation (CSO).

## 2 - Cancellation conditions

The cancellation conditions are those listed in this registration form, here below.

### 2.1 - Cancellation of tournament's registration and accommodation fees

- Cancellation received before January 4th, 2020: No withholding
- Cancellation received between January 5th, 2020 and April 13th, 2020: Withholding of 50% of deposit already paid for registering in the tournament
- Cancellation received after April 13th, 2020: Total withholding of the payments made for registering in the tournament.

**These cancellation fees also apply to any reduction in the number of persons initially registered with your delegation and accommodation reservation. All amounts will be due.**

### 2.2 - Cancellation of the event

Should, for reasons of absolute necessity (war, attacks, strikes, riots, bad weather, natural disaster, epidemics...) the tournament be cancelled, CSO will not refund the registered teams the sums already paid, for the registration and the journey.

In that case, CSO would do its utmost to have these sums held toward a rescheduled Mundiavocat tournament in Marrakech at some later date.

If, for reasons beyond the control of CSO, the tournament is definitely cancelled, the teams already registered will have to be responsible on a proportional scale for the amounts committed to by the CSO, above the amounts already transferred to BEN ACTIVTRAVEL & MC LUXURIES.
